GENERAL

1. School fees

School fees for 2025 include the following:

- All textbooks and learning materials (including the cost of e-books)
- Workbooks
- A basic stationery pack

School fees for 2025 exclude the following:

- The e-learning device and any insurance, maintenance or other costs relating to the device itself
- School uniforms
- Additional stationery that may be required
- Entrance fees, travel costs, accommodation and food for school excursions and sports trips, unless otherwise advised by the school
- School photos
- Therapists' and/or psychologists' fees

2. E-learning devices

E-learning devices will be utilised by all learners from Grade 4 to Grade 7.

This will have the following impact on you:

- If your child is not in Grade 4 to Grade 7, your child will receive hard-copy textbooks from the school.
- If your child is in Grades 4 to 7, you will be responsible for purchasing an e-learning device for your child to use. The school will provide you with details and the minimum specifications required for the device.
- You will be responsible for the insurance and general maintenance and care of the device.

The following costs associated with the use of e-learning devices are included in the school fees:

- The cost of all electronic textbooks (e-books)
- Access to Wi-Fi and Internet on the school campus
- Access to a school email account
- Access to an interactive communication platform with teachers

For subjects where electronic textbooks are not yet available, the school will provide your child with a hard-copy textbook.

3. Termination of enrolment
